This document serves to notify the Boarding facility listed above (hereinafter referred to as "Facility") where said horse, \_\_\_\_\_, identified as, \_\_\_\_\_, is boarded, that Voice For Horses Rescue Network, Inc. is the owner of said horse on paper. The individual listed herein as Boarder has adopted said horse, from Voice For Horses Rescue Network.

While we do not anticipate any problems between Facility and the adopter of said horse, this document serves to address several items that could arise.

- I. Facility, please be advised that should Boarder become more than 30 days late in payment of board for said horse, and Facility's policy is to either evict boarder, place a lien against said horse or sell said horse for back board, this document supersedes the terms in Facility's boarding agreement with Boarder (verbal or written) regarding disposition of said horse. If Boarder becomes more than 30 days late in payment of board for said horse or has other unfulfilled obligations to Facility and Facility plans to exercise their right to address this situation with Boarder, Facility agrees to notify Voice For Horses Rescue Network, in writing of the circumstances regarding Boarder and understands that said horse cannot be sold, evicted, bred or have a lien placed on him/her by Facility. Once Voice For Horses Rescue Network receives written notification from Facility that there is a problem and the horse can no longer remain there, Voice For Horses Rescue Network will remove said horse to alleviate further burden on Facility as soon as transport arrangements can be made.

- II. Facility understands that Voice For Horses Rescue Network. has no financial obligation to Facility. Voice For Horses Rescue Network. understands that Boarders are sometimes late with payments, and facilities are sometimes lenient in that regard. However, if this situation is a problem that Facility intends to address with Boarder, and the welfare of said horse is at risk, it is imperative that Facility contact Voice For Horses Rescue Network. immediately, in writing, to remove said horse. It is up to the owner of Facility to determine when to contact Voice For Horses Rescue Network, keeping in mind that Voice For Horses Rescue Network. will provide no remuneration to Facility for any monies (or indebtedness of any kind) owed by Boarder. Boarder has the only financial agreement with Facility.
- III. Should Boarder be in contract with Facility for partial board, and, Boarder is somewhat or entirely responsible for the care of said horse, Voice For Horses Rescue Network. asks the Facility to notify Voice For Horses Rescue Network. if said horse is not receiving proper care that Boarder is responsible to provide. At that time, c. Voice For Horses Rescue Network will address the concerns with Boarder to remedy the situation and improve the conditions for said horse or make arrangements to remove said horse.

Boarder understands and agrees that if Voice For Horses Rescue Network. is asked by Facility to remove said horse from the premises, Boarder immediately surrenders all rights to said horse and can no longer take part in

any activity with said horse from that day through our removal of said horse from Facility even if Boarder has paid board beyond the date that Facility contacted. Voice For Horses Rescue Network. If Boarder is providing partial care/feed/turnout, Boarder will however be responsible to continue to provide that care if Facility refuses to do so until horse is moved. \_\_\_\_\_initials of Boarder.

Should a dispute arise between Boarder and Facility, Boarder is solely responsible for resolving that dispute with Facility (boarding fees, supplements, farrier, dentist, damage, etc.), Voice For Horses Rescue Network /Diana Murphy, their/her associates, affiliates, assigns, successors, et al are held harmless for any and all of additional monies and/or damages in question.

And, finally, please be aware that although ownership of said horse does NOT transfer to the adopter/Boarder, liability DOES on the date said horse leaves Voice For Horses Rescue Network. Voice For Horses Rescue Network encourages adopters to purchase both health and liability insurance for the horse they choose. Voice For Horses Rescue Network feels insurance is a healthy financial investment of a minimal amount to ensure that the horse is properly cared for when a major health issue arises, and the adopter is protected should any accidents occur. Voice For Horses Rescue Network, Diana Murphy, their/her agents, affiliates, employees, representatives of all types, officers, Directors, their successors and assigns, et al is/are held harmless from liability in the event of an accident and/or incident and/or property damage and/or death involving said horse (directly or indirectly) while said horse is under the care of boarder and/or Facility. If you, the facility owner, have any questions regarding this document, please contact Diana Murphy (419) 350-4195. We do not anticipate a problem, but must protect the welfare of the horse should a problem arise.
